Test Content

1. Market data initialization abnormal drill

- Scenario 1: Pre-market product information (cpxx) documents error abnormal

Time: Around 8:45am

Phenomenon: Can download the cpxx file with incorrect date on the LDDS system around 8:45am (the file name is the current day) and can download cpxx files with correct data after 9:00am on the LDDS system.

Expected Situation: IVs can manually maintain the cpxx file based on the previous day or wait for the correct cpxx file to be issued to complete the initialization without affecting the services.

- Scenario 2: Part of the pre-market static files download abnormal

Time: Whole day

Phenomenon: IV will not receive the static files (mktdt00, mktdt02) and can receive real-time static file normally

Expected Situation: IV can use real-time files mktdt00 and mktdt02 for initial data on market, which will not affect providing market services.

- Scenario 3: Product short name (cpjc) file download abnormal

Time: Whole day

Phenomenon: IV will not receive product short name (cpjc) static file

Expected Situation: IV can obtain related product short name data through cpxx files or other channels, and will not affect providing market services.

2. Other test content

Can receive and handle Level-2, Level-1 market data

Test Checkpoint

- Static files receive and handle (cpxx, f jy, etc...)
- Market data initialization abnormal drill
- Level-2 and Level-1 market data can receive and handle
- System restores
