#### **1. Full Implementation of the Stock Issuance Registration whole network system test**

- 1) Relevant changes in Product Information File cpxx0201 and cpxx0202 including Main board stock price limit, Identification of securities names on the first day of listing and 5 days before listing, Special logo (UWD) and Registered logo;
- 2) Registration-based stocks real time market data receive and handle;
- 3) The display of the market terminal (Users who need to display refer to the market display guidelines, no mandatory requirements).
