Expected situation: can normally initialize through the cpxx0201 file

- When the cpxx0202 file is missing, the cpxx0201 file can be received and processed normally
- Level-2 and Level-1 market data can receive and handle
- FISP and Option market data receive and handle (if authorized)
- System restores
